Between 1922 and 2020, 86 people have served on the Board of Directors of the Rockwood Water District and the Rockwood Water People's Utility District.



From the beginning of the District the Superintendent was the "Chief Executive." It wasn't until the 1980s that the position of District Manager (later General Manager) was created. Two Directors served as Superintendent in the earlier days of the District.

The District's first Superintendent, C. H. Blocksom, served until 1937. Upon his resignation, S. J. Glasscock resigned from the Board and was appointed Superintendent. Mr. Glasscock served as Superintendent until called to active naval service in August 1940. He was replaced by Vaughn McCann, who served until December 1942. When he resigned he was replaced J. W. Spiller, who resigned from the Board to take the position. In the District's history, Mr. Glasscock and Mr. Spiller are the only two Board members who resigned in order to fill a position with the District.

One of the District's first Directors was Walker Quesinberry, who was very integral to the early history of the District. He owned and operated a hardware store at 182nd and Base Line Road (Stark Street today), and served on the Board of Directors from 1927 until his death in 1946. Between 1937 and 1945 District Board meetings were held at his hardware store. The District purchased land from him and rented storage space for equipment. He had a contract with the District as early as 1938 to collect payments for water bills for a 2% commission (as did five other businesses). Fred Quesinberry had such a contract in 1952. The District ceased the practice in 1995.
